We combine knowledge with impact – for agriculture and nutrition.

With its expertise, the BLE works as a co-design and implementation authority for sustainable agriculture, food, fisheries, and livable rural areas.

For over 30 years, the BLE has been the central interface between agriculture, food, the environment, and society. The agency is headquartered in Bonn. It supports the Federal Ministry of Agriculture, Food and Regional Identity (BMLEH) by implementing strategies and measures. The focus is on:

- → Control tasks, crisis management, and agricultural market stabilisation
- → Support for funding projects and implementation of federal programmes
- → Communication on agricultural and food issues

In addition, it provides administrative services to the BMLEH and other authorities. To ensure that everything runs smoothly from a technical perspective, the BLE's IT landscape is based on a data centre certified for IT baseline protection in accordance with ISO 27001.

Control tasks, crisis management, and agricultural market stabilisation

To ensure that we can enjoy safe food, it is crucial that we have quality control, transparency and traceability. It is equally important to maintain a reliable supply, even during crises such as natural disasters. Stable agricultural prices in the EU protect the interests of both consumers and producers.

As the market regulation authority, the BLE supports price stability and issues import and export licenses for agricultural products. It also implements EU law, such as the regulation on deforestation-free products (EUDR). The BLE performs a wide range of control tasks both on land and at sea. It monitors emergency food supplies for crisis situations. In the fisheries sector, the BLE carries out control tasks, cooperates with the Maritime Safety and Security Centre (MSSC), and operates three fishery protection vessels and three fishery research vessels.





Supporting funding projects and implementing federal programmes

Putting scientific findings into practice, driving innovation, or strengthening international cooperation: as a project management agency, the BLE supports research projects on behalf of the Federal Ministry of Agriculture, Food and Regional Identity (BMLEH) from the initial idea to practical implementation, thereby creating incentives for investment. The topics covered span the entire agricultural and food industry value chain. What they all have in common is future viability and sustainability.
